## SHARE DRAFT AGREEMENT

I/We, the undersigned, intending to be legally bound, hereby request that Norristown Bell Credit Union provide negotiable acceptance drafts for my/our use in effecting withdrawals from my/our share account. Norristown Bell Credit Union is authorized and directed to pay money unconditionally from said share upon drafts executed by the following persons:

Even if Norristown Bell Credit Union has received written notice of adjudication of incompetency and appointment of a guardian or death of the individual executing such a draft; and to accept assignments made to it (but only to it) by any one or more of us as collateral security for any loan or loans which it may make to any one or more of us; the power of any of us to exercise the above rights may be revoked by the written order of all signatories hereto, and that in case of death of either or any of us the balance then remaining in said account shall be the absolute property of the survivor or survivors and Norristown Bell Credit Union is hereby authorized and directed to deal with the survivor or survivors (with all the within rights of joint tenants), as the sole and absolute owner or owners of such sums.

Should Norristown Bell Credit Union receive any draft, as above, in an amount in excess of the balance then standing in the account as reduced by any amount which has been pledged as collateral security on any loan; it may, at its sole option, either pay the draft and charge this overdraft to my/our primary share account or decline to pay the draft. In the latter event or in the event either or any of us instruct Norristown Bell Credit Union not to pay a draft Norristown Bell Credit Union shall incur no liability for the non-payment of such draft and the undersigned, jointly and severally agree to indemnify and save harmless Norristown Bell Credit Union for any damages or expenses including any reasonable attorney's fees it might incur by reason of such non-payment. In the event of an overdraft or on any overdue loan payment account, NBCU reserves the right of set off against any/all electronic deposit vehicles.

Any objection respecting any item shown on a statement of the share draft account shall be waived unless made in writing to the credit union on or before the 10th day following the day the statement is mailed. The use of the share draft account is subject to such other terms, conditions, service charge and requirements as the credit union may establish from time to time.
